



## 2<sup>nd</sup> Joint Call for Proposals of TÜBİTAK - NARD Bilateral Cooperation Projects

### 1. Preamble

This announcement set out the rules for the submission, selection and implementation of bilateral cooperation Projects financed under the 2<sup>nd</sup> Joint Call for Proposals of TÜBİTAK – NARD.

**TÜBİTAK - The Scientific and Technological Research Council of Turkey**, is the leading agency for management, funding and conduct of research in Turkey. It was established in 1963 with a mission to advance science and technology, conduct research and support Turkish researchers. The Council is an affiliated institution for Ministry of Science, Industry and Technology and is governed by a Scientific Board whose members is selected from prominent scholars from universities, industry and research institutions.

TÜBİTAK is responsible for promoting, developing, organizing, conducting and coordinating research and development in line with national targets and priorities. In addition, TÜBİTAK carries out and monitors international scientific and technological collaboration activities with the rest of the world through Directorate for International Cooperation.

**NARD - National Agency for Research and Development** is a central administrative authority under the Government of Republic of Moldova that was established through the Decision no.196 from 28.02.2018.

NARD is responsible for implementation of the European Research Area priorities in the Republic of Moldova, by developing bilateral and multilateral cooperation activities through JPIs, ERA-Nets, COFUND, etc., supporting researcher's mobility, promoting Smart Specialization principles, Open Science opportunities and others. Among the key activities of the Agency, there are: implementation of the state policy in research, innovation and development; management of national development funds and funds from bilateral and multilateral programmes launched under cooperation agreements with international organizations and foundations; facilitation of partnerships between organizations in the research & innovation domain and public or private companies.

### 2. The objectives of the Call

The objectives of the call are:

1. To encourage international collaboration between research entities, universities, and research institutes (include private sector entities from Turkish side);
2. To facilitate the access to new research environments, facilities, knowledge and expertise;
3. To enhance the quality of research and enable the translation of research and innovation into economic and societal benefits, considering sustainable development.

## 2.1 Call Topics

- Engineering and Technology
- Medical and Health Sciences
- Agricultural Sciences
- Research in Social Sciences Related with COVID19 Pandemic

## 2.2. Joint research and development projects

a) Joint research and development projects are foreseen to be applied to this Call.

b) Project proposals have to provide detailed information on the objectives and justification of the planned joint research work, the methodology to be followed, the composition of each research team, the intended time schedule, the estimated results and dissemination strategy.

c) The results should be focused on innovative insights, exploitable research results and the creation of foundations for a well-founded and sustainable partnership between Moldova and Turkey, as well as to the call's objectives.

## 2.3. Funding Available

a) As a rule, Turkish partners that are eligible for funding can receive up to 720 000 Turkish Liras ( $\approx$ 110 000 EURO) (excl. overhead and Project Incentive Premium (PIP) approximately) of funding in total per project. The Moldovan partners that are eligible for funding can receive up to 800000 MDL ( $\approx$ 40 000 EURO) of funding in total per project. The funding will be provided simultaneously by TÜBİTAK and NARD in the form of non-repayable project grants.

**b) For the Turkish side** – funded costs of each grant will be issued and managed by TÜBİTAK in accordance with its funding guidelines and procedures.

**c) For the Moldovan side** – funded costs of each grant will be issued and managed by NARD according to its funding guidelines and procedures.

d) Co-financing is not mandatory, but is foreseen as an advantage.

e) Please liaise closely with prospective partners to ensure that both TÜBİTAK and NARD - supported elements of the proposal abide by all regulations for both funders.

## 2.4. Duration of the Projects and reporting

1. The duration of the projects will be up to **24 months**. The projects will be monitored for its content and progress by both NARD and TÜBİTAK through progress/final and financial reports according to funding contracts provisions.

2. During the implementation period of the projects, the continuation of funding will be decided on the basis of intermediate evaluations with reference to the results proposed in the application form and funding contracts.

3. Within two months after completion of the project, a final report, presenting the work carried out and the results obtained, will be prepared in English language jointly by the two research teams and submitted to TUBITAK and NARD.

### 3. Call Schedule, Eligibility and Submission

The 2nd<sup>st</sup> Joint Call will be **opened from 1 March 2021 to 31 May 2021 (17:30)** for online submission. Turkish and Moldovan applicants will elaborate joint project proposals (common application form), which will be submitted by the Turkish partners only via TÜBİTAK's online system reachable from <http://uidb-pbs.tubitak.gov.tr/>.

**Applicants and partners can participate in more than one project proposal.**

#### 3.1. Eligibility

It is a prerequisite that projects include the participation of one public research entity (eligible to NARD) independently or in partnership with other research or private entity from Moldova and research entity, university, research institute or private sector's representative from Turkey (eligible to TÜBİTAK).

All Turkish researchers who apply for this Programme should be registered to TÜBİTAK ARBİS (Researcher Information system) through the following link: <http://arbis.tubitak.gov.tr>. Further information relevant to national applicants/regulations:

Moldovan partners will have to submit signed supporting documents in electronic and the paper version, published in the Call announcement, according the Government Decision nr.382/2019.

#### 3.2. Proposal Submission

##### **For the Turkish side**

The Turkish applicants are expected to submit the online application and supported documents published by TUBITAK through UIDB-PBS system by **31 May 2021 (until 17:30)** and sign with e-signatures by **7 June 2021 (until 17:30)**, otherwise they will be rejected from evaluation and could not apply to this call in the same call period.

##### **For the Moldovan side**

The Moldovan applicants are expected to submit to NARD in one PDF file, the final version of the application form and the supported documents to: [info@ancd.gov.md](mailto:info@ancd.gov.md), by **31 May 2021**.

**Note:** The applicants may submit their applications throughout the entire period of the call for proposals, until the afore-mentioned deadline.

The online system will not allow submission of any Application after the deadline.

Applications sent to e-mail after the deadline will not be examined.

**Project proposals will be prepared in English.**

#### 3.3. Partnership Agreement:

a) Scientific and technological results and any other information derived from the co-operation activities under this Call, will be shared, announced, published or commercially exploited with the written consent of both cooperating partners and according to the international agreements concerning intellectual property rights to which states of the both Parties are signatories.

b) The partnership agreement about ownership of intellectual property rights and other duties

is a supporting document and has to be signed between cooperating partners and attached to the application form. The partnership agreement shall be concluded in compliance with national legal framework of the Parties.

## **4. The Evaluation Procedure**

Projects that are submitted online without the supporting documents and original or e-signature(s) will not be evaluated and thus will be not considered for funding. Only projects eligible for both sides, TÜBİTAK and NARD, will be evaluated.

### **4.1. Evaluation Method**

a) The proposals that are considered eligible will be reviewed by external reviewers selected according internal procedures by TÜBİTAK and NARD, and only those proposals that are approved by both Parties will be supported.

b) The projects to be recommended for funding will be selected together by TÜBİTAK and NARD.

On Moldovan side, the final decision about financing of recommended project proposals is made by NARD and on Turkish side by TUBİTAK.

c) Any dispute related to the interpretation or implementation of this Call shall be settled through consultations within the TÜBİTAK and NARD.

### **4.2. Evaluation Criteria**

The evaluation and selection process starts after the deadline of the call for proposal. The project proposals will be evaluated based on the following criteria:

- Scientific and Technological Excellence
- Methodology
- Project Management
- Importance of International Collaboration
- Impact
